5	4.The heat treatment should be carried out by the firm to obtain the necessary hardness (as per QA plan. After the heat treatment and NDT inspection, all mechanical properties tests should be carried out in the presence of RCI/RDAQA representative.		
6	5.Riveting and realization of the Wings & Fins is the responsibility of the vendor. The process of riveting shall get certified by R&QA and RDAQA.
